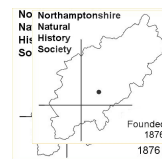

## General Data Protection Regulations (2018)

The NNHS will only hold and retain personal data for administering society membership, e.g. selecting membership category, distributing the journal/programme, advising subscription expiry, or for essential society business. The NNHS will not pass personal data to third parties without permission. Any personal data held will be encrypted and kept secure.

The NNHS will only keep the bare minimum needed to administer society membership and any information held is kept safe.

### Gift Aid

The NNHS is recognised by the Inland Revenue as a charity, and as such, the society can claim tax relief on membership subscriptions and donations made since 6<sup>th</sup> April 2004, provided we hold a signed GIFT AID form. The only requirement is that an equal amount of UK Income or Capital Gains Tax has been (or will be) paid which the society can then reclaim.

This tax refund is currently £8 for the privilege rate subscription or £10 for the full rate subscription.

Completing the form overleaf will allow the NNHS to reclaim tax paid on membership subscriptions and also on any other donations. Higher rate tax payers, paying tax at 40%, can claim a reduction on their personal tax bill.

Please note that if family or a joint membership is taken out each member should sign a separate gift aid declaration. If there are any queries on this scheme, please contact me.

I would urge eligible members to sign the declaration as the society can increase the value of subscriptions received at no extra cost to members (a £40 subscription becomes £50).

However please note the gift aid form should not be completed if tax is not paid in this country
